WORK FOR STUDENTS SELF-ISOLATING DUE TO COVID-19

Students who are absent from school because they have had a positive COVID-19 test result but are not sick, have work provided for them from their teachers in Teams, The Student Learning Environment or via Show My Homework (Satchel One).

Any other students absent from school due to sickness do NOT have work provided for them. If students do not have COVID-19 and are well enough to work, they should be in school. Teachers will not provide work for absences other than self-isolation due to COVID-19. Students who are absent due to illness should not email teachers for work, they should focus on rest and recuperation to help them get well so that they are able to return to school as soon as possible.

ROAD SAFETY UPDATE – ROADS AROUND FULLBROOK


Road Restrictions Outside Fullbrook Main Gates

The short stretch of highway which lead off Selsdon Road and forms the approach to the main gates of Fullbrook is not to be used as a drop off/pick up point under **ANY** circumstances. There are road markings and signs which under the Highway Code mean you are committing an offence (Sections 5 & 8 of the Road Traffic Regulation Act 1984) if you ignore them.

Yellow Zig Zag Lines (on left hand of stretch of road approaching the Fullbrook gates) - Keep entrance clear of stationary vehicles, even if picking up or setting down children. These lines are supported by a sign next to where the lines are painted, telling people that there is no stopping during the times shown.



Double Yellow Lines (on the right hand side of road approaching Fullbrook gates) - No waiting at any time.



This means **under no circumstances** should vehicles other than those accessing the houses immediately next to the Fullbrook site, or needing to access Fullbrook premises (staff/deliveries) be waiting/parked on this stretch of road. Runnymede Parking Enforcement Team and Runnymede Police have been requested to patrol over the coming weeks, and will be taking action if they feel that there is a violation to the parking controls in place or an offence is being committed.



Voluntary One Way System

We ask parents and carers to observe a voluntary one way system when using cars to drop off/pick up students. This helps to ease the flow of traffic in a very tightly packed residential area where cars are parked on the road, and home owners need to be able to leave and access their driveways.

The volume of cars around the school entrance and Selsdon Road continues to be a hazard for pedestrians along with other road users, including staff trying to access the Fullbrook site.



We appreciate that the absence of a school bus service means that more students are travelling to and from school in cars, but the volume of parents/carers dropping their child as close to the school gates as possible is having a huge impact.

A reminder of the voluntary one-way system is on the next page.

Safe Pick Up/Drop Off Points

Ideally, if you were able to drop your child/children somewhere that is in a quieter location where they can then walk to school, this would help to reduce the congestion around the school. Suggested alternatives are below.

Orchard Avenue, Woodham – students can walk safely down the alley which brings them out by the Fullbrook main gates. If you do use this road, please do not park on the grass verges as this damages the turf which then leads to the residents complaining to the school.

Woodlands Avenue car park, West Byfleet – students can cross the canal bridge and walk up the alley way that runs between the Fullbrook school buildings and the Fullbrook sports field/3G pitch and comes out at the Fullbrook main gates.

The Broadway, New Haw – lots of spaces for cars to stop, and a great place for students to meet friends from their year group bubble before walking to Fullbrook together.



Innovate IFG

Dear Parents,

The Food Information Amendment, also known as Natasha's Law, is coming into effect from the 1st October 2021. It places a responsibility on all food businesses to provide a full list of ingredients and allergen labelling on all food prepacked for direct sale. The purpose of this letter is to advise you of IFG's commitment to be fully compliant with this new law in time for 1st October 2021.

IFG have always embraced our responsibilities in the identification of allergens and have rigorous procedures in place. We continually work with our suppliers to ensure that the allergen information we hold for our raw ingredients is as accurate as possible. All our recipes have been tried and tested by our team of food development chefs who, by using approved buying lists, can make sure that our recipes are made to exact specifications and standards.

In order to adapt to Natasha's Law, we have reviewed our labelling systems so that we can be confident that the information on our labels is accurate. The foods that are affected are those that we pre-pack and place within our fridges and counters, including sandwiches, baguettes, salad boxes, pasta pots, and dessert pots. From October 2021, they will have a full label, that clearly identifies the food item. There will then be a complete list of ingredients and the allergens will be highlighted using a bold font within the ingredients list as shown in the example below:




We are delighted that the new labels will make it easier for people with food allergies to make fast, informed, and safe food choices from our prepacked food. This new labelling system should not detract from the importance of notifying your schools of any pupils with food allergy needs, and communicating these through to our Executive Chef/Catering Manager on site. Please note that there is a separate allergen diet process to be completed for primary school pupils. If you have a child in primary school requiring an allergen diet please ask your school for details of how to make a request.

I hope you have found this informative and that it provides you with confidence that IFG have the procedures and systems in place to provide you with accurate allergen information for the foods we serve whilst fully satisfying the requirements of Natasha's Law.
