#### **DANGEROUS DRIVING & PARKING**

We are receiving an increasing number of complaints from members of the public about the lack of courtesy being shown towards others by parents and carers driving their children to school and parking during drop off/pick up times. Some of the issues we've had reported include;

- Cars driving down the wrong side of Scotland Bridge Road when traffic is queuing for the bridge, just so that they can turn into Selsdon Road quickly rather than waiting
- Cars not leaving a safe distance between other vehicles to allow pedestrians to cross the road safely
- Vehicles parked on double yellow lines and zig zags to wait for students
- Blocking resident access to their properties by parking across driveways
- Parking on bends or across junctions

Next week we will be reaching out to Surrey Police and Runnymede Borough Council to request support with this ongoing issue, but we also ask that you please show care and consideration when making a car journey to or from the Fullbrook site.

#### NOTICE ON CURRENT POLICY ON COVID-19 ISOLATION

Following the changes to Government guidance at the end of February, our current policy is that students who have had a positive covid test result should isolate for 5 days. Please do an LFD test in the morning of Day 5 and again 24 hours later in the morning of Day 6. If both tests are negative your child can then return to school the same day. Government guidance will change again later in March.We will update you on these changes at that time.

Dear Parent/Carer

#### **Re: Year 9 Diphtheria/Tetanus/Polio final school booster and the Meningococcal ACWY vaccination e-consent.**

We continue to use e-consent for the school-based immunisation programme and this can be completed on any platform i.e. mobile phone, tablet or computer. However, in the event that this is not possible please contact the Immunisation team.

**Diphtheria/Tetanus/Polio (3-in-1 teenage booster)** is a final school booster protecting against diphtheria, tetanus and polio. This vaccination will complete the baby injections given pre-school.

**Meningococcal ACWY** protects against the four strains of meningitis known as ACWY. These diseases are known to affect older adolescents, especially if they go to university or training where they are living in accommodation with other young people.

Your child is due to receive the final school booster and Meningococcal ACWY vaccinations on **Tuesday 19<sup>th</sup> April 2022 or Wednesday 20<sup>th</sup> April 2022**.

Please complete an e-consent form for the vaccination (s) you would like your child to receive. If you do not want your child to receive a vaccine then please fill in the `NO' box.

**Complete the e-consent form at:** <u>www.surreyimmunisations.co.uk</u> (your school's unique code/URN number is **SR137003** which you will need to enter)

Please complete the e-consent form by **4pm on Tuesday 12<sup>th</sup> April 2022** (when the website portal will close). This allows time for our nurses to review and contact parents and carers if there are any concerns prior to the session.

An automated email will be sent to you on completion of the consent form from Cinnamon Digital Applications (who host the website portal for us). If you do not receive this please check in your junk email or contact the Immunisation Team.





Parents and carers who have not submitted their consent form by the deadline and wish their child to be immunised will need to call the Immunisation team.

#### Measles, Mumps, Rubella (MMR) Information

#### **GDPR**

On the 25 May 2018 the new EU General Data Protection Regulation (GDPR) came into force bringing with it improvements to Data Protection Regulations. Article 6 (1) (e)

For the performance of a task carried out in the public interest or in the exercise of official authority.

#### Article 9(2)(h)

Necessary for the reasons of preventative or occupational medicine, for assessing the working capacity of the employee, medical diagnosis, the provision of health or social care or treatment or management of health or social care systems and services on the basis of Union or Member State law or a contract with a health professional.
